YEAR-END GIVING CONSIDERATIONS

As 2022 comes to a close, now is the time to reflect on year-end gifts to provide further support to *Called to Renew*, the Archdiocese of Los Angeles, your parish or other ministries and organizations.

There are many ways to make the most of charitable giving. While some people prefer a simple gift of cash, others choose to give appreciated stock or make a distribution directly from an IRA.

Gifting securities, real estate, or other assets that have increased in value can have significant tax advantages. If you itemize tax deductions, you may receive an income tax deduction up to the full market value of the securities you gift to the campaign as well as avoid capital gains tax on the appreciation. You save on both income tax and capital gains tax.

A year-end distribution from your IRA can also be a tax-advantageous gift. If you are 70½ or older, the IRS requires you to take required minimum distributions (RMDs) each year from your tax-deferred retirement accounts. Amounts distributed as a qualified charitable distribution (QCD) can be counted toward satisfying your RMD for the year, up to \$100,000, and can also be excluded from your taxable income.

- For your gift to be eligible for a tax deduction for 2022, it must be postmarked by December 31, 2022, when mailed to the Archdiocese of Los Angeles.
- The Archdiocese must receive credit card donations, stock transfers, and gifts of securities by 11:59 p.m. PST on December 31, 2022.
- RMDs must be deposited into the Archdiocese bank account by December 31, 2022. Due to the Christmas holiday, the Archdiocese requests receipt of your RMD by December 16, 2022 to ensure timely processing.

Parish Spotlight

St. Francis Xavier, Burbank

Father Sebastian Vettickal approached *Called to Renew* like he does everything else in life — with a positive spirit.

Instead of thinking only about the money he would need to raise, the pastor of St. Francis Xavier Parish in Burbank chose instead to focus on "the renewal of the Church, renewal of my parish."

He approached the campaign as he does every challenge that comes his way — as an opportunity. "Only challenges and opportunities will help me to bring what's best in me, and also to do what's best for the community," he said.

Father Vettickal decided to host listening sessions with every parish group and committee, and asked members what the parish was doing well and their dreams for the community. "During COVID, everything was in a dormant stage," he said. "This was an opportunity to bring them back to life. That's where we renew the parish."

Knowing Called to Renew was not something he could, or should, do alone, Father Vettickal created a leadership team from the group and committee members with whom he met. Together, they also decided on an enhanced goal of \$900,00 to try and achieve the dream projects the groups and committees came up with: expanding and modernizing the parish hall, adding a modern science lab to the school, planning for maintenance projects, and building an outdoor activity facility for Masses, school activities, and parish events.

Father Vettickal embraced the opportunity to meet with parishioners, and enlisted the help of leadership to create a video specifically for their campaign. St. Francis Xavier has now raised \$1.05 million and will receive \$757,500 once pledges are fulfilled.

"Once people are excited, it is easy to talk about money — because if you've got dreams, then how do we make it happen?" he said. "Money comes second. Renewal comes first."

"My focus was not money — I focused on faith and renewal. Money will come if people's faith is ignited."
